- 1. CALL TO ORDER: 6:33 pm
- MEETING MINUTES: January meeting minutes were reviewed with no changes. Sarah makes a motion to approve, Eddie seconds. All are in favor - the motion passes.
- 1. REPORTS: (75 minutes)

#### a. President (Carrie) - President's report:

- The OSHA meeting was January 27th. This coming season will be a rule-change year. 18U
  will go back to icing on the penalty kill, and touch up off-sides, those are two important
  takeaways
- ii. They have instituted a "player safety" position at each association level. If a player gets a concussion for example, the person in that position will make sure that proper procedures are followed after the injury. They will monitor neck guard certifications, HECC certification, and will be in charge of making sure forms are filled out etc. This position will report to OSHA.

#### ii. Tournaments (Onalee Edwards) - Tournaments Report:

- Onalee is not present, but Sarah reports that they have the schedule out, and

  out for scorekeeping, raffles, etc. The Ice Cup will be smaller this year all in all, but
  will still be a fun event and way to get back into it. The committee will meet about
  making next year better. Sarah will connect with Eddie and Joel to get skill comp
  information passed along.

#### e. Team Reports:

- i. 18U -
  - Blue Deb says that they are busy and getting ready for the next tournament in Bremerton.
  - 2. Gold Jason reports that they were in Tri-cities, and played 3 games in 8 hours. They played Klamath Falls in the finals, and beat them, but then lost to them at Klamath last weekend. They are joining blue in Bremerton. There are 12 teams at that tournament. They are excited for the challenge. Their team has been sick, but healing up.
